Field name	Length	Comments
Group	2	Banks and financial institutions are divided into bank groups. The following groups currently exist: 1 = Swiss National Bank 2 = UBS Group 3 = Reserved 4 = Credit Suisse Group 5 = Credit Suisse Group 6 = Entris banks 7 = Cantonal banks 8 = Raiffeisen banks and individual institutions 9 = PostFinance
IID	5	Each bank / financial institution is identified by an IID (institution identification). The IIDs are three to five digits long.
Branch ID	4	The branch ID combined with the IID produces a unique key for each entry. Each IID has a main branch with a branch ID of "0000"; branch IDs of "0001" and above are assigned to the branches for that IID.
New IID	5	If this field contains a number, the IID is no longer valid (e.g. as a result of a merger) and must be replaced by the "new IID" (known as concatenation). Concatenation will always be carried out with the branch ID ("0000") of the new IID. The original information will remain unchanged in the other record fields until concatenation is canceled.
SIC IID	6	This is always a six-digit number and may be used only by SIC and euroSIC participants.
Headquarters	5	IID of the headquarters
IID type	1	This field shows the type of entry: 1 = Headquarters 2 = Main branch 3 = Branch
Valid since	8	Date from which the information in a record is valid. This date will be adjusted as soon as a change has been made in at least one field or in the case of a record that is included in the file for the first time.
