Terms of Use

The Tick Data Service is only available for registered participants of SIX Swiss Exchange (SSX) or corresponding SIX Exfeed customers. Link, user name and password are for exclusive use of the Company, which is the contracting party to this Agreement (“Company”). Historical Tick Data published in the protected section on SSX’s website or downloaded from any other source or interface may not be copied, reproduced, republished, redistributed, resold, sublicensed, posted, broadcasted or transmitted in any other way by the Company to any third parties for commercial gain without prior written consent from SIX Exfeed. The Company shall be permitted to download, store temporarily, retrieve and display Tick Data from the protected section on SSX’s website or any other source or interface on a computer screen and store such information in electronic form on disk for its own use.

Fee for Historic Price Data on Demand

The non-recurring, one-off fee for a calendar month (~20 trading days) worth of Tick Data amounts to **CHF 1,250.00 per month, excl. sales tax (VAT)** and is available for download as described above. The service provides the accumulated files of the current month plus the history of the last 11 months on a rolling basis. We would like to remind you that the authorisation to download the files will be terminated at the end of the predefined month/s (“Download Period”). Services provided in Switzerland and Liechtenstein are subject to VAT. The appropriate fee shall become due when invoiced and payable within thirty (30) days of the date of the invoice. SIX Exfeed shall be entitled to change fees unilaterally at any time. Amendments to fees have to be communicated electronically or by mail not later than three months before the become effective.

This Agreement commences on the date it is signed by the Company, or other date agreed in writing between SIX Exfeed and the Company and terminates automatically on expiry of the Download Period.

SIX Exfeed shall only be liable for willful misconduct and gross negligence. In any case, SIX Exfeed’s liability for any indirect or consequential loss or damage (howsoever arising), including loss of profits, loss of turnover, loss of bargain, loss of opportunity, loss of software or data, loss in connection with any trading interruptions in connection with the above mentioned Tick Data Service is excluded.

Applicable Law and Place of Jurisdiction:

This Agreement shall be governed by Swiss law. The exclusive place of jurisdiction for any disputes arising out of or in connection with the Agreement shall be Zürich, Switzerland.
