

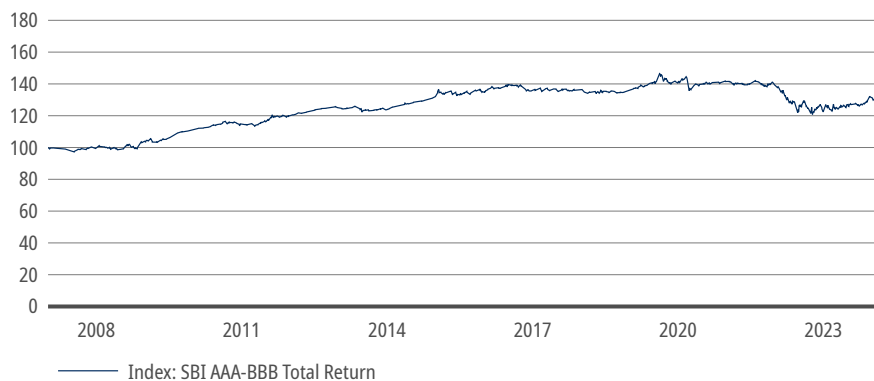


SBI AAA-BBB Total Return

Index Description

The SBI AAA-BBB TR (SBR14T) reflects the development of the CHF bond market by tracking most of the Swiss-franc-denominated bonds listed on SIX Swiss Exchange. It therefore provides valuable macroeconomic insights into the Swiss capital market. On December 29, 2006, the SBI AAA-BBB TR was standardised at 100 points. In order to be included in the index, a bond must have a remaining term to maturity of at least one year as well as a nominal amount of at least CHF 100 million. In addition, only fixed-rate bonds with a minimum credit rating of "BBB" are included. In this regard, SIX determines a so-called "composite rating", which is derived from the ratings of Standard & Poor's, Moody's and Fitch as well as those of Swiss banks Credit Suisse, UBS, Zürcher Kantonalbank and Swiss rating agency Fedafin. Given that the SBI AAA-BBB TR is the broadest bond index of SIX and for the purpose of this factsheet, its price version SBI AAA-BBB TR (SBR14T) is shown as a comparison.

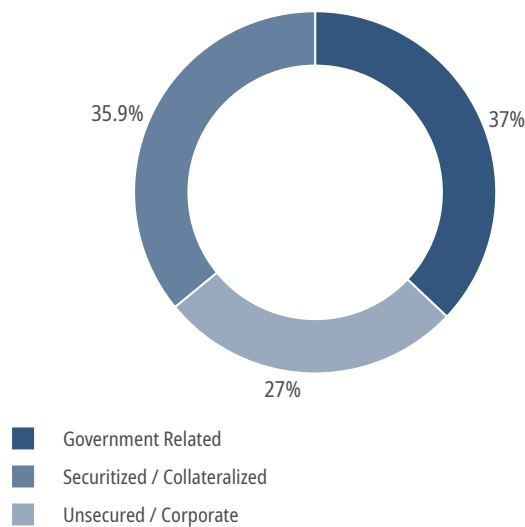

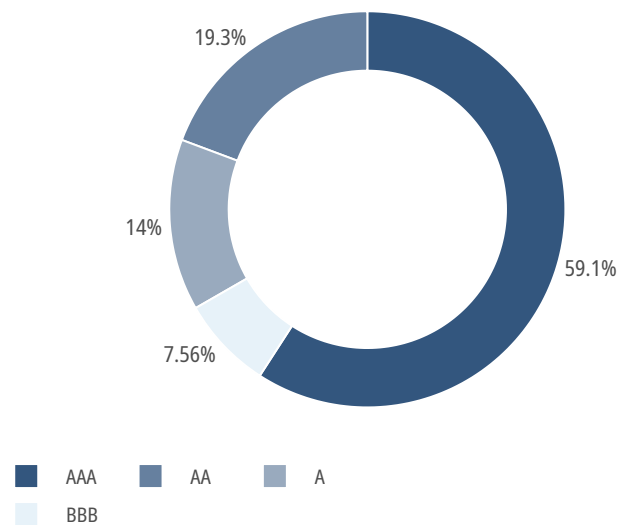
