


# **SPI Select Dividend 20 Price**

### **Index Description**

The SPI Select Dividend 20 PR (SDIVI) index measures the development of the highest-yielding instruments of the SPI. It includes the 20 instruments with the highest dividend paying record and a solid profitability of the SPI. The components are weighted by their dividend yield. On March 19, 2007, the SPI Select Dividend 20 PR (SDIVI) was standardised at 1000 points. As of today the index represents more than 19% of the freefloat market capitalization of the entire Swiss equity market. Its benchmark Swiss Performance Index SPI PR (SPIX) covers 99% of that market.




