

SPI® Select Dividend 20 Total Return

Index Description

The SPI® Select Dividend 20 TR (SDIVIC) index measures the development of the highest-yielding instruments of the SPI. It includes the 20 instruments with the highest dividend paying record and a solid profitability of the SPI. The components are weighted by their dividend yield. On March 19, 2007, the SPI® Select Dividend 20 TR (SDIVIC) was standardised at 1000 points. As of today the index represents more than 18% of the freefloat market capitalization of the entire Swiss equity market. Its benchmark Swiss Performance Index SPI® Total Return (SXGE) covers 99% of that market.

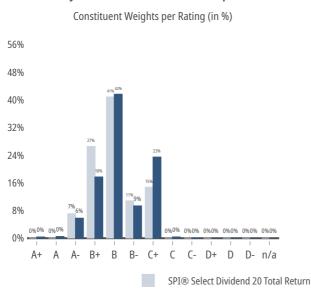

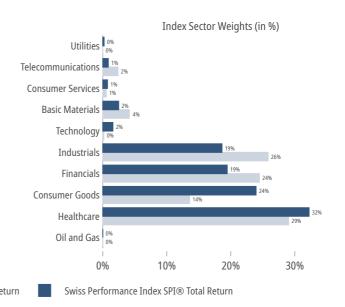
