

Swiss Leader Index SLI® Total Return

Index Description

The Swiss Leader Index SLI® TR (SLIC) index measures the development of the extended Swiss Blue Chip equity market. The 30 largest and most liquid equity instruments traded at SIX are selected as components. The index composition is fixed to 30 shares which are generally freefloat market capitalisation weighted. The SLI applies a capping scheme to increase the weight of smaller components and therefore distributes the risk exposure more equally among all components. The index is standardised at 1000 points on December 30, 1999. It covers roughly 52% of the entire Swiss equity market compared to 99% of Its benchmark Swiss Performance Index SPI® Total Return (SXGE).




