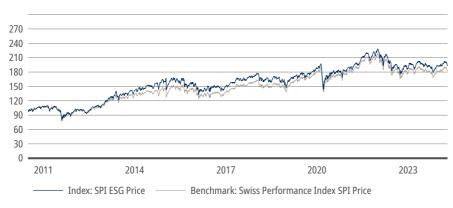


SPI ESG Price

Index Description

The SPI ESG PR (SPIE) measures the development of Swiss equities based on ESG Ratings provided by Inrate. The index consists of those components of SPI which have at least a rating of C+ on a Scale from A+ to D-. To be selected for the index, all instruments are subject to revenue limits in the following sectors: adult entertainment, alcohol, armaments, gambling, genetic engineering, nuclear energy, coal, tobacco and oil sands. In addition instruments must not been recommended for exclusion by the Swiss Association for responsible Investments (SVVK-ASIR) and need to fulfill the United Nations Global Compact (UNGC) assessment. The components are weighted by their Freefloat Market Capitalisation. On July 01, 2010 the SPI ESG PR was standardised at 100 points. As of today the index represents more than 97% of the freefloat market capitalization of the entire Swiss equity market. Its benchmark Swiss Performance Index SPI PR covers 99% of that market.

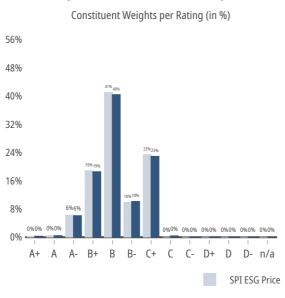
