
SPI ESG Select Price

Index Description

The SPI ESG Select PR (SPIEU) measures the development of Swiss equities based on ESG Ratings provided by Inrate. At the index review date the components are selected for the index until it contains half the number of components of the SPI. The components are selected depending on their ESG Rating and their size in Market Capitalisation. To be selected for the index, all instruments are subject to revenue limits in the following sectors: adult entertainment, alcohol, armaments, gambling, genetic engineering, nuclear energy, coal, tobacco and oil sands. In addition instruments must not been recommended for exclusion by the Swiss Association for responsible Investments (SVVK-ASIR) and need to fulfill the United Nations Global Compact (UNGC) assessment. The index actively controls component weights to reduce cluster risks. Therefore a UCITS capping is applied to control if two components exceed a weight of 20%.




