

# SPI Reversal Premium CHF (Total Return)

# **Index Description**

The SPI Reversal Premium CHF (TR) (SPIRVC) identifies equity instruments of the Swiss equity market expecting a trend reversal based on a statistical pattern. The index is a variable component index with a limit of 30 shares. Its components are weighted by an equal contribution to risk and their weight is limited to 8%. On December 31, 2003 the SPI Reversal Premium CHF (TR) was standardised at 100 points. As of today the index represents more than 0% of the freefloat market capitalization of the entire Swiss equity market. Its benchmark Swiss Performance Index SPI TR (SXGE) covers 99% of that market.

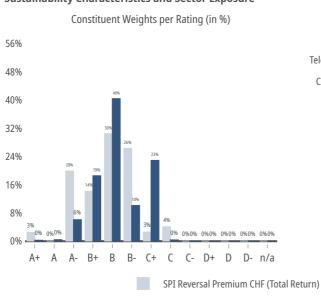

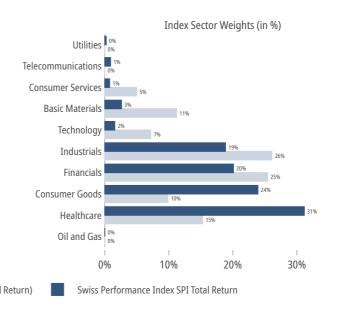
