



SXI Switzerland Sustainability 25 Price

Index Description

The SXI Switzerland Sustainability 25 PR (SSUSTX) measures the development of Swiss companies which are considered sustainable according to a measurement framework provided by Inrate. The index has a fixed composition of 25 components which is reviewed annually. The components are weighted by their freefloat market capitalisation and capped at 15%. On December 30, 2008 the SXI Switzerland Sustainability 25 PR was standardised at 100 points. As of today the index represents more than 42% of the freefloat market capitalization of the entire Swiss equity market. Its benchmark Swiss Performance Index SPI® Price (SPIX) covers 99% of that market.

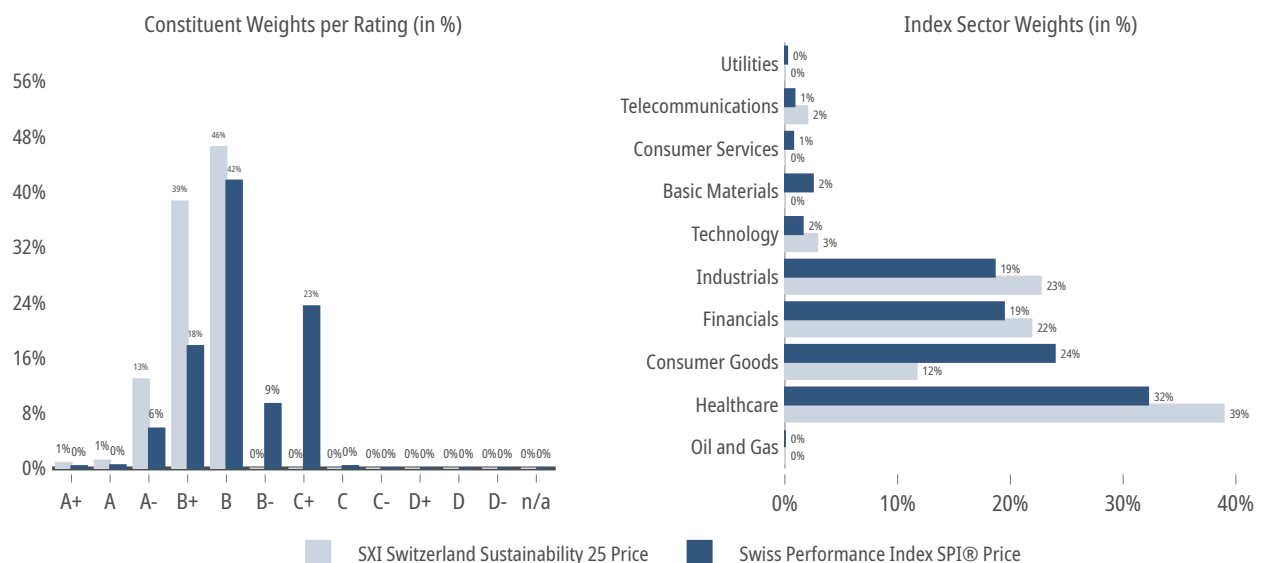
