

SPI® ICB Industry 6000 "Telecommunications" Total Return

Index Description

The SPI® ICB Industry 6000 "Telecommunications" TR (C6000T) index measures the development of the sector Telecommunications within the SPI. The sector definition is based on the sector classification standard of ICB with 9 Industries and 18 Supersectors. The SPI Sector Indices are variable components indices with their components weighted by freefloat market capitalisation. The index was launched on January 01, 1996 and standardised at 1000 points as of December 31, 1999. As of today the index represents more than 0% of the freefloat market capitalization of the entire Swiss equity market. Its benchmark Swiss Performance Index SPI® Total Return (SXGE) covers 99% of that market.




