1) Controversial weapons are defined as anti-personnel mines, cluster munitions, nuclear weapons, bio & chemical weapons, depleted uranium and white phosphorus  
2) Average human rights performance is calculated by using indicators about the use of death penalty in a country, fundamental rights and the number of human rights conventions signed. Each indicator is assigned a normalised value between 0 and 100 and weighted by 33.3%, 16.7%, and 50% respectively.  
3) For the average income inequality score, the GINI index by the Worldbank is being used. It measures the extent to which the distribution of income (or, in some cases, consumption expenditure) among individuals or households within an economy deviates from a perfectly equal distribution.  
4) Average freedom of expression score is calculated by using indicators press freedom index, political rights score, and civil liberties score. Each indicator is assigned a normalised value between 0 and 100 and weighted by 28.6%, 28.6%, and 42.8% respectively.  
5) Average corruption score is represented by the corruption perception index of Transparency International.  
6) Average political stability score represented by the political stability index of the World Bank  
7) Average rule of law score is calculated by using indicators about fundamental rights, constraints on government powers, open government, order and security, regulatory enforcement, civil justice, criminal justice, and absence of corruption. Each indicator is assigned a normalised value between 0 and 100 and are equal weighted.
