Dear Vendor,

Based on the [SIX Exfeed message no 11/2015](#), we would like to inform you about the new Data Center in Lupfig and the ordering of the new Line.

Network migration to the NEW SIX IP (cutover) is already done, therefore we will deactivate the OLD SIX IP over the weekend, 27-28 February 2016

The Schlieren SIX Exfeed System environment (**secondary site, disaster-failover/test**) will be physically moved from Schlieren to Lupfig Data Center on 13th August 2016

Please note that the deadline for establishment of the new lines is June 30th 2016. As of end of September 2016, the Data Center Schlieren will be decommissioned and therefore all SIX Exfeed lines which are connected to Schlieren must be replaced with the new circuit with end point Lupfig. The **PRIMARY** Site remains in Hardturm and the **SECONDARY** Site will be Lupfig.

We would like to remind you that the vendor owns and is solely responsible for the management and operation of the communication infrastructure (routers, leased line) from their sites to the dedicated port(s). At present, all well-known carriers run POP (Point of Presence) equipment within both data center sites (*such as Swisscom, COLT Telecom, Verizon Business, Sunrise*).
