Last June, SIX announced the acquisition of BME. Our longer term integration program has been recently publicly outlined. The relevant details are available on:

We are happy to announce a first wave of innovative integration steps enhancing the market data distribution infrastructure. The BME data content currently disseminated via the “BME Data Feed” will be migrated to the SIX “Multi Dimensional Data fluX” (SIX MDDX®) interface during Q4 2021.

Who is impacted?

- All BME clients currently connected to “BME Data Feed”

What will change?

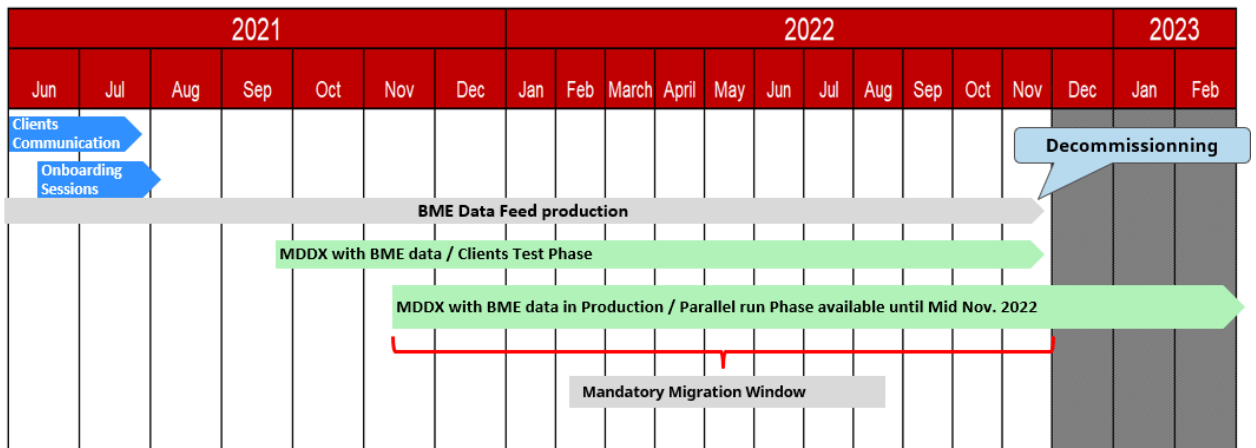
- BME data content will be only available via the SIX MDDX®; this is a purely technical migration
- “BME Data Feed” existing infrastructure will be decommissioned at the end of 2022

What won't change?

- Existing contractual agreements between BME Market Data and its clients consuming “BME Data Feed” will remain unchanged

When?

- BME data via SIX MDDX® in testing environment from September 2021
- BME data via SIX MDDX® in production by late November 2021
- 12 months parallel run of “BME Data Feed” and SIX MDDX® feed from November 2021 until November 2022
- All clients must complete the migration during the parallel run; There will be no extension of the parallel run period.
