SIX Swiss Exchange will introduce a **new SWXess Maintenance Release (SMR13)** for the SWXess trading platform.

- SMR13 contains required interface changes for SWXess participants.
- SMR13 will be introduced into the Membertest environment with a staged approach on **18 March 2024** and **15 April 2024**.
- SMR13 is scheduled to go live in the Production environment on **10 June 2024**
- The "SMR13 Release Guide (Version 1.00)" has now been published

Introduction

SIX Swiss Exchange will introduce the SWXess Maintenance Release 13 (SMR13) to the SWXess trading platform. SMR13 contains required interface changes for SWXess participants.

The key highlights of SMR13 are:

- Introduction of Quote on Demand for Swiss Franc Bonds incl. Post-Trade Transparency (delayed Publication functionality)
- Enhancements to Quote on Demand Trading Service
- Amendments following the update of RTS 1 and RTS 2
- Further changes to be confirmed in due course

SMR13 will be introduced in the **Membertest environment** with a **staged approach; stage 1 on 18 March 2024 and stage 2 on 15 April 2024**. SWXess interface **changes** required to support the functionality of both Membertest stage 1 and stage 2 will be delivered with **Membertest stage 1**.

SMR13 is scheduled to go live in the **Production Environment** on **10 June 2024**.
