- SMR15 is scheduled to go live in the Production environment on **12 May 2025** with a contingency date on 30 June 2025

1 Introduction

SIX Swiss Exchange will introduce the SWXess Maintenance Release 15 (SMR15) to the SWXess trading platform. SMR15 contains required interface changes for SWXess participants.

1.1 Timetable

SMR15 will be introduced in the **Membertest environment** with a **staged approach; stage 1 on 3 March 2025 and stage 2 on 31 March 2025**.

SMR15 is scheduled to go live in the **Production Environment** on **12 May 2025** with a contingency date on 30 June 2025.

1.2 Changes

SMR15 will introduce the following changes

- with Membertest Stage 1
 - Enhancements to the SwissAtMid Block Trading Service
 - Enhancement to Retail Order Types Stop Loss and Stop Limit
 - QOD CHF-Bonds - QTI support for one-sided quotes
 - QOD CHF-Bonds - "Must-have" Liquidity Provider for QOD Requests
 - Separation of Snapshot and Delta Channels via MDDX
 - Connectivity to ARTEX Global Markets
 - Connectivity Upgrade between SIX Swiss Exchange and Clearing Houses
- with Membertest Stage 2
 - Enhancements to QOD Requests with Sweep
 - Additional functionality may be added and announced in due course
