Fri 9 January 2026	All day	Upgrade SWXess Trading Platform to include SMR16 Membertest functionality.
	Approx. 16:30	Confirmation will be published on the system status page in the Member Section (and MSC Alert for Subscribers) that the upgrade has been completed.
	Following confirmation until 20:00	SWXess systems are running, connectivity is possible, however markets are closed and orders/quotes will be rejected.
Sat 10 January 2026	11:00 – 20:00	SWXess systems are running, connectivity is possible, however markets are closed and orders/quotes will be rejected.
Sun 11 January 2026	All day	Contingency Day. SWXess systems are closed, SCAP is available.
Mon 12 January 2026	As from 06:00	First trading day on SMR16 in Membertest environment (M01) with functionality.

- Publication of Theoretical Opening Price during Non-Opening Condition
- Introduction of Stop Trading Check after Non-Opening
- Redesign of the Member Section Login Process
- Redesign of the SIX Reporting Application
