### Harmonization of SIX Analytics Service

As part of our ongoing efforts to simplify and standardize access to our services, SIX Exchanges, including SIX Swiss Exchange, Bolsas y Mercados Españoles and Aquis Exchange, are unifying all Analytics Products under a unified contractual framework. This update will encompass both existing and future Analytics Products, ensuring consistency across our offerings.

 **Please note:** While the terms of the SIX Analytics Agreement remain largely unchanged, the update aligns all analytics offerings under one unified legal structure.

 **Important:** Existing customers of SIX Analytics Services do not need to take any action - including customers who also hold a BME Analytics subscription. The updated SIX Analytics Agreement will govern all Analytics Services across SIX Swiss Exchange, BME and Aquis, and will allow existing SIX Analytics customers to order BME and Aquis Analytics products and vice-versa. **Customers who subscribe only to BME Analytics will need to enter into the new SIX Analytics Agreement to continue receiving the service.**
