In [SIX Swiss Exchange message no. 60/2012](#) we announced that the productive implementation of SWXess Maintenance Release 3 (SMR3) would be delayed.

The results of our consultation show that participants will be ready to switch to the new release as of 10 December 2012.

This message provides confirmation of the new productive implementation plan for SMR3 as well as important information relating to the upgrade.

Trade reversals and counter-trades

In [SIX Swiss Exchange message no. 58/2012](#) we informed participants that no trade reversal fees will be charged until 31 January 2013. Due to the new productive implementation date for SMR3, this promotion has now been extended until **31 March 2013**.

SLS service

We have received confirmation from our partner Liquidnet that our joint SIX Swiss Exchange Liquidnet Service (SLS) will also be available in full from Monday, 10 December 2012.
