Action required 

In [SIX Swiss Exchange message 38/2013](#), we announced that the productive implementation of the optional SWXess Maintenance Release 3.1 (SMR3.1) would be postponed.

The postponement became necessary as we received indications from the market that participant own applications had to be changed at short notice due to the release.

This message informs participants about the new production rollout plan for «Sponsored Access» with SMR3.1 and provides some additional, important details.

### Rollout

SIX Swiss Exchange has, in agreement with the participants, decided to roll out «Sponsored Access» with SWXess Maintenance Release 3.1 (SMR3.1) as follows:

Date	Environment
17 / 18 August 2013	<b>Migration</b> to SMR3.1 in Production
19 August 2013	First trading day with Sponsored Access in the <b>Production</b> environment
