Please note that SIX Swiss Exchange is offering a 2 month fee holiday for the new London-based Access Point service. The 2 month fee holiday is offered under the following conditions only:

- The fee waiver is only valid for applications received by email or with valid proof of posting (postmark) by SIX Swiss Exchange no later than six months after the launch of the Access Point service (between 2 March and 1 September 2015). Applications received thereafter are not eligible for the fee waiver.
- The fee waiver is only available for current participants with SCAP connectivity.

Participants interested in using the new London-**based** Access Point are kindly invited to submit the «<u>Connectivity Form</u>» to their respective Local Support Centre.
