- Introduction of regulatory-driven changes regarding FMIA and MiFIDII

SIX Swiss Exchange is introducing a further upgrade of its SWXess trading platform as part of its ongoing improvement efforts. SWXess Maintenance Release 7 (SMR7) is a **mandatory** upgrade which will mainly **implement any required regulatory-driven changes** regarding the [Swiss Financial Market Infrastructure Act](#) (FMIA) and [MiFIDII](#) as well as introduce further enhancements and optimizations in On Book Trading, Trade Reporting and Post-Trade Processing. In addition SIX Swiss Exchange will launch the new SIX MDDX Multi-Dimensional Data fluX™ interface (SIX MDDX) which fulfils the regulatory requirements for market data distribution.

SMR7 is scheduled to go-live on **24 July 2017 in the Membertest** environment and on **23 October 2017 in the Production** environment. The contingency date for the go-live in Production is 4 December 2017.

Please find all currently known business relevant information concerning SMR7 in the «[SMR7 – Participant Readiness](#)» brochure published with this message. The brochure contains information about functional changes and regulatory impact of SMR7 as well as details concerning the migration, testing phase and rollout. In addition, the publication contains links to several other SMR7 relevant documents.
