SIX Swiss Exchange is pleased to announce the introduction of the new "Reporting Agent" role enabling middleand back office employees of trading participants to submit on exchange – off order book trade reports to the Exchange.

Reporting Agents will be registered with the Exchange and receive a dedicated and personal Reporting Agent Identification. Reporting Agents will need to prove the expertise required for trade reporting by means of a reporting examination which mainly consists of reporting regulations, functionalities and post-processing.

The "Reporting Agent" role will replace the current service of a participant as a reporting member according to clause 5 of <u>Directive 1: Admission of participants</u>.

## **Reporting Agent Exam**

Registration to the Reporting Agent examination as well as the corresponding preparatory documentation will be available as of 23 October 2017 on our website (link). The multiple-choice exam is conducted with the same set-up as for the trader examination - online at the participant's premises under the supervision of the responsible Head Exam (Compliance Officer).

A preparatory course will be offered to prepare the examinees in the best possible way.

## **Transitional Provisions**

The new "Reporting Agent" role is scheduled to go live on 23 October 2017 with the introduction of the SWXess Maintenance Release 7 (SMR7). At the same time the existing Reporting Member setups for exchange participants including the Reporting Group Trader Identifications will be decommissioned. Please note that Reporting Agent IDs already set up in membertest environment will be automatically migrated to the production environment as of 23 October 2017.

SIX Swiss Exchange offers a **transitional period** for participants registering Reporting Agents from the start of SMR7 in the production environment. The transitional period allows Reporting Agents to submit trade reports to the Exchange starting on 23 October 2017 but they will have to pass the Reporting Agent examination by **Friday, 29 December 2017 at the latest**.

If the Reporting Agent does not pass the examination by end of 2017, the Exchange will cancel the provisional registration as of 3 January 2018 and notify the participant accordingly.
