The Access Point will have two points of presence and will offer a reliable and resilient connection as well as the opportunity to reduce current connectivity costs.

- The fee waiver is only valid for applications received by email or with valid proof of posting (postmark) by SIX Swiss Exchange no later than six months after the launch of the Access Point service (between 8 January and 7 July 2018). Applications received thereafter are not eligible for the fee waiver.
- The fee waiver is only available for current Participants, Data Vendors and Service Providers with SCAP connectivity.
