In [SIX Swiss Exchange message no. 39/2018](#), SIX Swiss Exchange informed Participants about the start of the Membertest phase of the optional SWXess Maintenance Release 7.2 (SMR7.2), which comprises expansions and optimizations in the field of trading in the order book and without pre-trade transparency, as well as in the bilateral, off-exchange trading of structured products. In addition the groundwork for the replacement of the MDI market data interface by the SIX MDDX Multi-Dimensional Data flux™ (SIX MDDX) interface for participants will be laid.

This message informs participants about the publication of the trading regulations for SMR7.2.
