### Content of this message:

- Migration of Blue Chip Shares to a new Trading Segment (ID 25) in the context of the decommissioning of market code “XVTX”
- Publication of updated “SMR9 Participant Readiness” brochure and “Release Notes for SMR9”

In [SIX Swiss Exchange message no. 34/2020](#), the Swiss Stock Exchange confirmed the start of the Membertest phase for the mandatory SWXess Maintenance Release 9 (SMR9), which will introduce the new “Quote on Demand” trading service and will decommission the market code “XVTX”.

This message informs participants about the migration of the Blue Chip Shares to a new trading segment in relation to the decommissioning of the market code “XVTX”.

### Participant Readiness

With SMR9, the Swiss Stock Exchange will decommission the Market Identifier Code “XVTX” for Blue Chip Shares on 7 December 2020 and replace it by the Market Identifier Code “XSWX”. At the same time, all Blue Chip Shares will change to a new trading segment.
