### Content of this message:

- SMR9.1 will introduce new mandatory enumerator values in both market data interfaces (IMI, SIX MDDX) and QTI changes affecting Liquidity Providers and Market Makers in Structured Products. The changes in the other interfaces are optional.
- Initial publication of “SMR9.1 – Participant Readiness” brochure
- Initial publication of the updated specifications of the SWXess interfaces and “Release Notes for SMR9.1”
- SMR9.1 is scheduled to go into the Membertest environment on 29 March 2021 and to go live in the Production environment on 10 May 2021.

As part of its ongoing optimization efforts, SIX Swiss Exchange is introducing a further upgrade of its SWXess trading platform. The SWXess Maintenance Release 9.1 (SMR9.1) will introduce new **mandatory** enumerator values in both market data interfaces (IMI, SIX MDDX) and QTI changes affecting Liquidity Providers and Market Makers in Structured Products. The changes in the other interfaces are optional.

SMR9.1 will mainly introduce enhancements to the trading service “Quote on Demand”, optimizations for Market Makers/Liquidity Providers in Structured Products as well as other on book trading relevant improvements.
