Prior to that, he was CEO of Benkar A.Ş. within Boyner Holding, based in Turkey, from 1997 to 2001 and Consultant and Partner at McKinsey & Co from 1992 to 1997, where he was responsible for establishing a McKinsey office in Turkey. In his former roles as CEO, he successfully launched new credit cards, set up innovative credit card programs and established an effective organizational structure for credit cards within a bank.

Jürg Weber currently serves on the Board of Directors of Orascom Development Holding AG, based in Altdorf, Switzerland, and Aviva Sigorta A.Ş., based in Istanbul, Turkey. He is also Chairman of the Board of Directors of Bensys Holding, based in Amsterdam, Netherlands. He holds an MBA, with a major in Finance and Strategic Management, from the Wharton School, University of Pennsylvania. Jürg Weber previously studied Civil Engineering at the School of Engineering in Switzerland and Microeconomics and English at the University of California, Santa Barbara.
