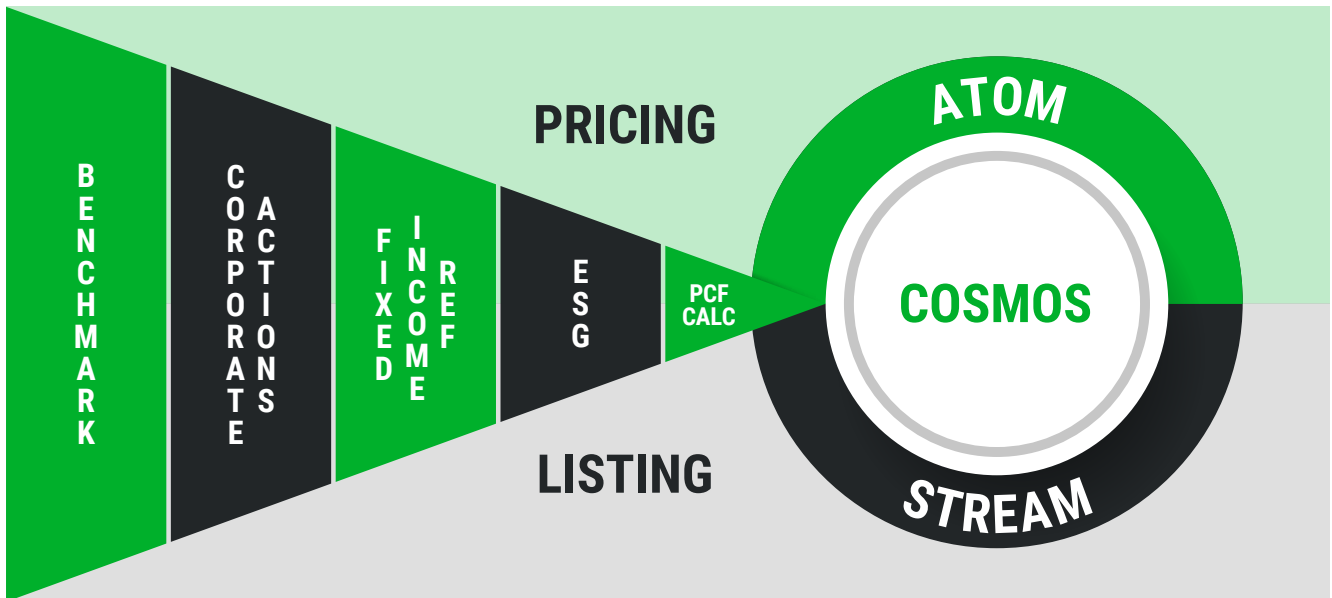

DATA INPUTS

● ETF PCF Calculation

ULTUMUS is the market leading service provider for the calculation and distribution of synthetic and physical PCFs to all participants in the Exchange Traded Funds trading Space, across equity, fixed income, commodities and crypto. ULTUMUS is the specialist in creating bespoke workflows to enhance data and ensure files are distributed ahead of market open, driven by our global team.

● ETF Global Corporate Action

ULTUMUS provides the award winning SIX corporate action feed, designed specifically for the ETF market, such that ETF issuers and a authorized participants have full visibility of upcoming corporate actions that are going to impact their respective baskets, this provides a deep and comprehensive view on a global basis.

● ETF ESG & Social Positioning Ratings

ULTUMUS provides real time ESG and Social positioning across a global universe of stocks, allowing ETF issuers to grade the impact of their products down to the constituent basis and allow for real time monitoring of changes. This can also be aggregated by ULTUMUS providing an independent rating of the funds themselves.

● ETF Benchmark Feed

ULTUMUS has access to all the main index providers, these can be supplied as part of a feed / report to the ETF issuer for use on their website or as in input for the PCF calculation (subject to the licensing requirements of the index provider).

● ETF Fixed Income Reference

ULTUMUS has created its own repository of fixed income reference data to assist with the paucity of data available in conventional PCF files. This additional reference data is designed to supply clients with data such that the bonds can be bucketed into segments that are aligned. The referential data we populate, includes items such as: issue date, maturity date, coupon, coupon frequency, seniority and par value.

DATA DISTRIBUTION

- **ETF Global Composition Feed**

For distribution to the required Authorised Participants and Market Makers, ULTUMUS has a feed of global ETF composition data into all the main ETF participants. This is a comprehensive mechanism for distributing all trading information to all required participants and exchanges.

- **ETF Atom**

ULTUMUS provides a data distribution mechanism to automate the distribution in the required format of the regulatory, classification, legal structure and countries available for sale. The distribution mechanism includes 3rd parties such as WM Daten, Fundinfo and Funds Library.

- **ETF Stream**

Allows for the comparison / analysis on a global basis of funds using a similar benchmark or classification / region exposure. ULTUMUS provides a feed of AUM, NAV and shares with appropriate referential data such that reports can be generated over any desired time period.

TRADING

- **ETF Cosmos**

ULTUMUS has worked with a number of issuers and market makers to create a generic and standardised creation redemption platform, designed to interface with the market makers via API, creating a STP to their OMS. This single platform creates a platform that is web deployed to the majority of ETF participants.
