



Historical Data

Our historical data services provide a detailed record of past market activity on SIX Swiss Exchange and BME Exchange, including transaction prices, orders, volumes, and corporate actions, offering valuable insights into market behavior over time and allowing clients to test their algorithms and others trading strategies.

Switzerland:

Historical Price Service (HPS) delivers daily all tick-by-tick data per partition (equity and non-equity). Distributed via a web-based download, the service is available to all interested customers.

HPS files are an exact copy of the ITCH Market Data Interface (IMI) payload (see section 6.6.1 in the ITCH Market Data Interface (IMI) Specification).

Spain:

BME counts with ample sets of historical information at the disposal of the client, which provide the exact copy of the data provided in real time by MDDX and the BME Gate Servers. Historical data is available for the last 40+ years.

Connectivity

With a wide range of options to access the SWXess and BME trading platforms, participants can select the right type of connectivity for their trading strategy and market activity.

SIX Common Access Portal (SCAP): SCAP provides scalable access to the SIX Swiss Exchange trading platform, including Trading & Market Data Interfaces. It has high data-transmission capacity with a connection that can be tailored to traders' requirements and market activity. Communications between traders and platform are conducted through an encrypted VPN tunnel and secured by Internet Protocol Security (IPSec) and Internet Key Exchange Protocol (IKE).

Co-Location Services: Access via Co-Location services hosted in the Zurich-based Equinix datacenter (SWXess) and internal datacenter in Las Rozas (BME) is the ultra-low latency access to our trading platforms of the Swiss and BME Stock Exchanges.

Proximity Services: For the lowlatency through a direct connection, traders can connect to SWXess via a designated proximity service provider. This overcomes geographical distance and offers the same low latency to international clients as to those located in Zurich. BME provides these services at the DXC datacenter, 10 km away from the BME trading platform.

Access Point Services: The Access Point service enables traders to optimize connectivity to all exchange services and asset classes available from the Swiss and BME Stock Exchanges. We offer direct connectivity with low and reliable latency via points of presence in:

SWXess: London (Interxion LON1 & Equinix LD4/LD5) and Frankfurt (Equinix FR2 & FR4).

BME: London (Interxion LON1 & Equinix LD4).



Order Entry Feeds

Switzerland:

Standard Trading Interface (STI): Provides basic trading and reporting capability, designed for customers not seeking highspeed, high-volume proprietary trading and market making.

OUCH Trading Interface (OTI): Connects participants directly with both the SWXess Equities and Non-Equities On Book Matcher (OBM) Partitions.

Quote Trading Interface (QTI): Connects participants directly with the SWXess Non-Equities On Book Matcher (OBM) Partition. Participants have guaranteed transmission capacities for entering quotes or one-sided quotes.

Reference Data Interface: reference data files (master data and corporate actions) are provided to clients in CSV daily files.

SIBE Smart terminal: allows users to

seamlessly enter and manage order, as well as monitor real-time market data that is installed on the client's servers.

FIX Interface: developed under FIX 5.0 protocol, it provides a full set of trading capabilities for all the market segments traded in BME.

Provides Vendors and Market Participants with real-time market data and bespoke data sets from SIX Swiss Exchange and BME (based on Regulatory Technical Standard requirements, using the SoupBinTCP point-to-point and multicast network protocols) and third-party content.

Reference Data Interface (RDI): A file download interface that provides participants with all trading-related and participant-related reference data. The reference data is processed and made available for download as a set of CSV files on a daily basis.

ITCH Market Data Interface (IMI): Connects traders and data vendors with the securities and non-securities elements of the on-book matcher. It provides the highest possible speed for low-latency data, giving traders exceptionally high levels of performance.




