Declaration and recording of contemplated securities transactions

The securities transactions conducted on SIX Swiss Exchange may not be intermixed with the other activities of the subsidiary or branch office in Switzerland, but instead must be clearly separated from those other activities. The reporting and journal-keeping obligations are to be fulfilled at the registered office of the applicant. The same applies to all backoffice activities of the applicant.

Domicile of Service in Switzerland

Art. 11b Swiss Administrative Procedure Act, APA (Verwaltungsverfahrensgesetz, "VwVG") requires an applicant for authorisation as a foreign participant in a Swiss trading venue to maintain an domicile for service in Switzerland. This provision applies to any formal application filed by a foreign person/legal entity to a Swiss authority.

A domicile for service is an address in Switzerland to which a Swiss authority may deliver a decree and an invoice. It does not necessarily need to be a Swiss law firm.

The foreign supervisory authority must confirm in writing that:

- a) the foreign securities trader is subject to appropriate supervision in the country of domicile;
b) the competent foreign supervisory authority does not object to the foreign securities trader operating in Switzerland;

- Copy of the organizational regulations
- Organizational chart of the company or the company group
- Copy of the extract from the Commercial Register
- Latest annual report, including balance sheet and income statement
- Representative's power of attorney (original document) if applicable
- A copy of the domicile country's applicable provisions pertaining to the code of conduct and compliance with the journal-keeping and reporting obligations of a securities dealer. The competent supervisory authority can be of further assistance if necessary.
- Auditor's statement
- Signatory list certified by compliance (Please ensure that all signatories on this application form are part of the signatory list)
