The investigation will examine whether Accu Holding Ltd has filed the application regarding the share split in due time towards SIX Exchange Regulation.

Investigatory proceedings will continue for an indefinite period. SIX Exchange Regulation will announce the findings, however, no information will be provided while the investigation is ongoing.
